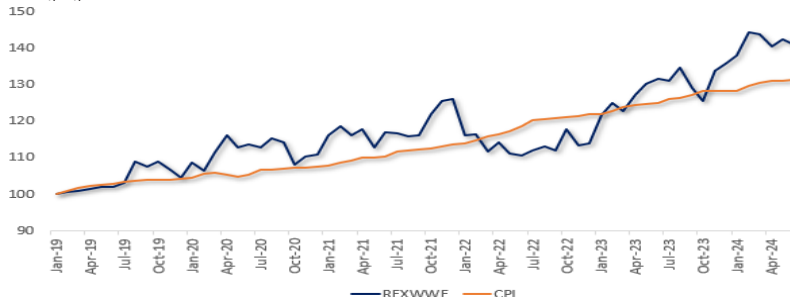

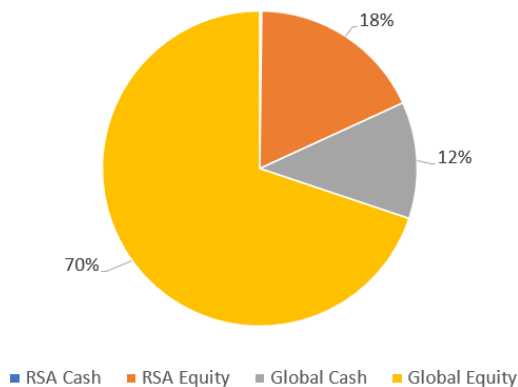

The Rexsolom Worldwide Flexible Fund ended the month -1.0% weaker, but in Dollar terms higher by 2.3%. For the quarter, the fund ended -1.9% weaker, but for the first half of the year the fund is 4% higher in ZAR terms. The fund maintains its 12-month Dollar return of 10.9%. The divergence in stocks listed in America continues with technology stock returns far outweighing other stocks. From the 15th of April, this divergence has been driven even wider. The S&P 500 price index managed to achieve a return of 27% over the last 3 years, whereas the equally weighted S&P 500 index managed to achieve a return of 9% over the same period. At some point, either the broader stock market catches up with technology stocks which is heavily weighted in the S&P 500, or technology stocks will run out of steam. The largest contributors to returns stemmed from Adobe, Microsoft, and locally listed Clicks and AVI after local stocks rebounded post-elections. The largest detractors during the month were Leonardo and CTT Correios de Portugal.

During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.

Disclaimer for Fund specific risk

Default risk: The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
